### Guide to Presenters and Session Chairs

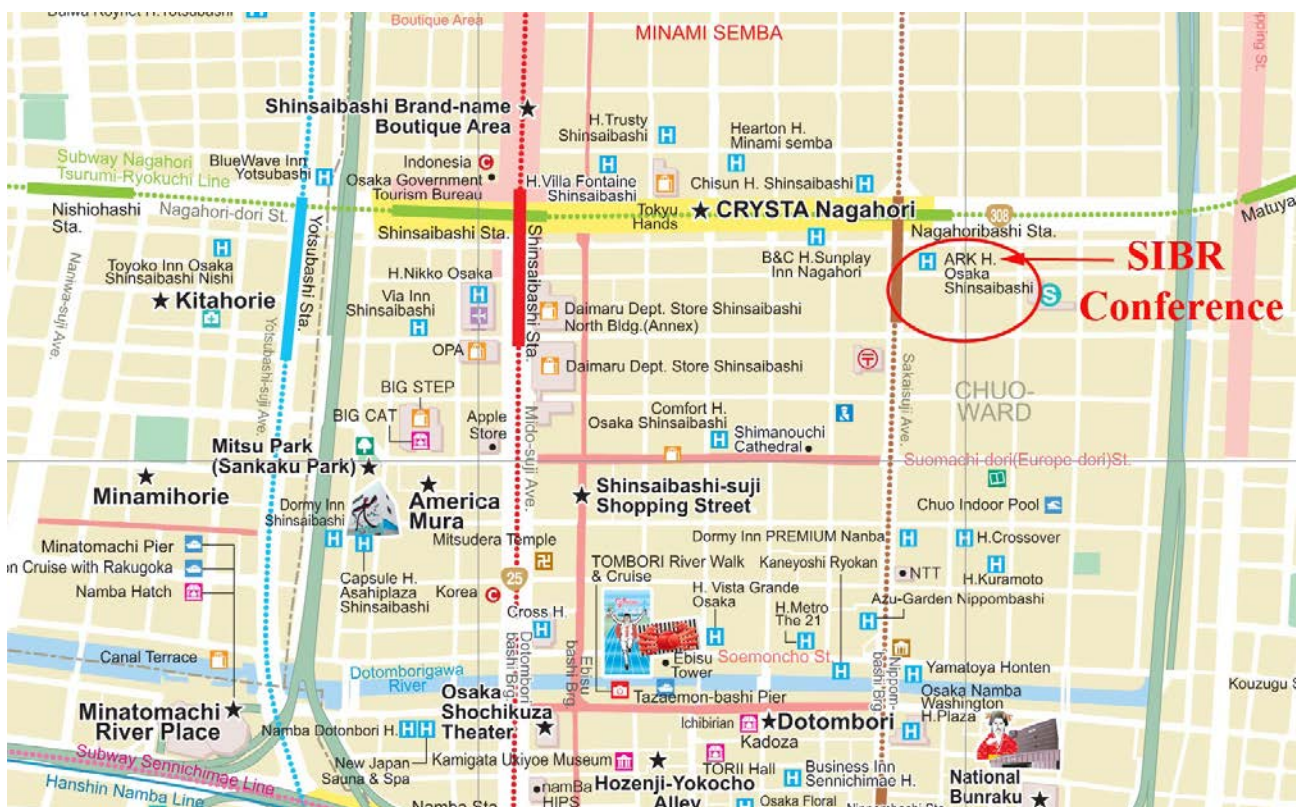
- Please be ready in the session five minutes before the schedule.
